### Range Resources Supports WHS Children's Therapy Center


Range Resources has supported WHSF for 15 years, and in more recent years began providing grants to the WHS Children's Therapy Center (CTC), which offers invaluable treatments and services to local children with special needs. In 2022, Range provided a grant that made CTC new sensory rooms possible and allowed the staff to purchase special physical therapy equipment.

In November 2022, Range Resources made a donation to purchase sensory learning equipment, a vibration plate, and a wall ladder. Employees from Range Resources were able to tour our McMurray location and see the items they donated which will benefit both Washington and McMurray locations. The staff at WHS CTC explained how beneficial these items are that are used daily and expressed their gratitude for Range Resources' support.

In addition to their annual support, new this year, Range Resources introduced "The Community Spotlight Project." This project helps raise awareness for local nonprofits through their traveling event exhibit which features signage with QR codes highlighting eight local organizations. WHSF is one of those featured non-profits.

As part of this project, the non-profit organization that receives the most votes through October 31 will receive a \$10,000 grant from Range Resources! You need not be present at any of these local events to vote, simply scan the QR code to vote and help Children's Therapy win!

### Make a Gift Tax-Free With an IRA:

#### A Tax-Saving Way to Help Washington Health System Foundation

If you are 70<sup>1</sup>/<sub>2</sub> years old or older, you can take advantage of a simple way to benefit Washington Health System Foundation and receive tax benefits in return. You can give up to \$100,000 from your IRA directly to a qualified charity such as ours without having to pay income taxes on the money. This popular gift option is commonly called the IRA charitable rollover, but you may also see it referred to as a qualified charitable distribution, or QCD, for short.

#### Why Consider This Gift?

- Your gift will be put to use today, allowing you to see the difference your donation is making.
- You pay no income taxes on the gift. The transfer generates neither taxable income nor a tax deduction, so you benefit even if you do not itemize your deductions.
- If you have not yet taken your required minimum distribution for the year, your IRA charitable rollover gift can satisfy all or part of that requirement.

Q. When do I need to make my gift?A. We must receive your gift by Dec. 31 for your donation to qualify this year.

Q. I have two charities I want to support. Can I give \$100,000 from my IRA to each?
A. No. Under the law, you can give a maximum of \$100,000. For example, you can give each organization \$50,000 this year or any other combination that totals \$100,000 or less.

Q. My spouse and I would like to give more than \$100,000. How can we do that? A. If you have a spouse (as defined by the IRS) who is 70½ or older and has an IRA, he or she can also give up to \$100,000 from his or her IRA.
